

“2023 LOGITECH G MONTH OF GAMING” PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian and New Zealand residents **aged 18 years or over**.
3. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
4. Entries into the promotion open at 12:00am AEDST on 03/04/2023 and close at 11:59pm AEST on 30/04/2023 (“**Promotional Period**”).
5. To be eligible to enter, individuals must purchase a ‘Logitech G or Astro’ product from any offline or online retailer in Australia or New Zealand authorised to sell Logitech G and Astro products during the Promotional Period. For the sake of clarity, this includes Logitech Australia and Logitech New Zealand e-shops.
6. To enter, individuals must then visit (AUS) <https://www.logitechg.com/en-au/monthofgaming> or (NZ) <https://www.logitechg.com/en-nz/monthofgaming> follow the prompts to the promotion entry page, input the requested details (first name, last name, address, mobile number, email address) including the details of the product purchased, the place of purchase and upload an image of the receipt and then submit the fully completed entry form during the Promotional Period.
7. Multiple entries permitted, subject to the following: (a) only one (1) entry permitted per transaction; and (b) each entry must be submitted separately and in accordance with entry requirements.
